By making an application for the Right To Be Caymanian, you agree to cooperate with the Caymanian Status and Permanent Residency Board ("the Board") or its duly appointed agents by providing such information or documents as they may reasonably request in connection with your application.

If the Board has reasonable grounds to believe that any fact stated in any application for the Right To Be Caymanian (including any affidavit sworn in support of such application) is false in a material particular, the Board or its duly appointed agents may conduct a full investigation in such manner as it deems fit.
